# **Financial Option Program**

Del Oro Jr. Golden Eagles (DOJGE) wishes to ensure all interested/eligible children are provided an opportunity to join the football and cheerleading program. Toward that goal, a financial option program (FOP) is available to parents/guardians who may need registration fee financial assistance. The following three (3) FOP options are available for consideration/approval. A signed contract shall be required to finalize an FOP agreement. (See attached copy).

### **OPTION 1: REGISTRATION PAYMENT PLAN**

The DOJGE Registrar and parent/guardian shall develop an agreed-upon payment plan for the registration fee only, *(If for a cheerleader, uniform must be paid in full by the due date set by the VP of Cheer,)* which will ensure payment in-full by July 1st of the applicable season. Failure to pay the account in full by the agreed upon date of July 1st of the applicable season will result in your athlete being benched until such time as the account is paid.

### **OPTION 4: FULL SCHOLARSHIP PLAN** (this option can be used only once)

A full scholarship plan (FSP) is available as a one-time only option for the entire time a child participates in the DOJGE. The FSP shall include the full registration and uniform costs. The parent/guardian shall complete and submit the scholarship program application for consideration. The DOJGE Executive Board shall award two (2) football and two (2) cheer applicants for the FSP per season.

I understand that there are fixed costs for my child to participate with DOJGE football or cheer, and by requesting a scholarship from the league I am requesting funds be distributed from a fixed scholarship fund that will limit other children from receiving like funds. In exchange for consideration for any of the above, I agree that my child will participate fully by attending all practices and games possible and complete the full DOJGE season we are applying for.
